Debra Bartos Cahill made the motion to approve the 2nd reading of Ordinance No. 003052019-01 ordering an election to be held on Saturday, May 4, 2019, for approval or rejection of the following local sale and use tax proposition: "the reauthorization of the local sales and use tax in the City of Florence, Texas at the rate of one-fourth of 1 percent to continue providing revenue for maintenance and repair of streets." Debra Bartos Cahill made the motion to approve the 2nd reading of Ordinance No. 003052019-03 ordering an election to be held on May 4, 2019, for the additional purpose of submitting for approval or rejection a proposition to authorize the sale of City parkland property as described below under the provisions of Sec.253.001(B) of the Texas Local Government Code: 104 Church Street, Florence, Texas (formerly City swimming pool) more particularly described as Lot 2 & Lot 3, Block 5, of the O.B. ATKINSON (NEW) ADDITION to the City of Florence, Williamson County, Texas, according to the map or plat thereof recorded in the Office of the County Clerk of Williamson County, Texas; SAVE & EXCEPT a tract of 0.03 acres conveyed by Deed dated September 5, 1984 of record in Volume 1069, Page 347, of the Official Records of Williamson County, Texas. Candy Kyle seconded the motion. Mayor Mary Condon asked to poll the Council.
